**Functions of the Committee:**

1. To review the implementation of Housing Scheme for Scheduled Castes and Vimukat Jatis.
2. To review the implementation of all other schemes of the Department of Welfare of Scheduled Castes and Backward Classes.

**Other**

1. The Headquarter of the Committee will be the concerned District Headquarter.
2. The Committee will meet at least once in six months.
3. The terms of the non-official members will be for a maximum period of 3 years from the date of the notification. However, the State Government may nominate or withdraw a non-official member at any time.
4. TA/DA will be given to the non-official members (excluding MPs/MLAs) at the rate of Group 'B' officers of the State Government for attending the meeting along with actual Bus/Train fare.
